**NO 14**

Multiple billions of dollars for more government funds for the failed, bankrupt and ethically questionable practice of embryonic stem-cell research through CIRM. There is no legislative accountability. Built in conflict of interests; board composed of potential grant recipient candidates.

CIRM President receives \$490,000 more pay than U. S President, even with delivering only failures, and no fiscal accountability. The original Proposition 71 got more than \$6 billion (after interest) 'lured a gullible public with candy-coated promises.' This measure doubles-down by promising even more miracle cures to the emotionally vulnerable public.

Heavy ideological influence of pro-abortion entities (CTA and NEA unions) have squandered and redirected school funds that were intended for 'repairs, renewals, and replacements.'" (EC Section 17070.75). In addition, the \$6.9 billion of annual income from the State Lotto dedicated to schools has been squandered by the political machinery of these entities giving Planned Parenthood direct access to public-school children.

This unconscionable redirection of school funding for ideological purposes should not be honored by providing even more money to be again squandered away.

Current law prohibits the use of government funds to discriminate for any reason including race, yet STATE funds are routinely distributed to Planned Parenthood, which intentionally targets the minority community for abortion. Incredibly, this measure repeals existing law and specifically allows ALL forms of intentional discrimination – including by abortionists!

As noted above, government schools have become free-access zones for Planned Parenthood and the abortion industry.
